

Dakotafest 2026 Woman Farmer/Rancher of the Year Award
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER

IDEAg Group LLC (“IDEAg” or “Sponsor”), a subsidiary of American Farm Bureau Federation, is accepting nominations for a woman to be honored as Dakotafest 2026 Woman Farmer/Rancher of the Year (the “Contest”).

Eligibility:

- Entries may be completed by families, relatives or friends of an eligible female farmer or rancher or by the nominee herself.
- The entrant/nominee must farm or ranch as a sole proprietor or one part of a couple, family or partnership.
- The entrant’s/nominee’s farm must be located entirely within the state of South Dakota.
- The entrant/nominee may work outside the home or farm but must contribute to the farming/ranching operation in addition to the duties outside the farm.
- The award ceremony will be held on the Dakotafest grounds in the Dakotafest Education Building, on Thursday, August 20, 2026, at 10:30 a.m. The top five finalists are encouraged to be available to attend the ceremony on the date and time selected.
- The selected woman farmer must agree to be featured in Dakotafest advertising, news stories and social media.
- Entrant/nominee must provide at least 1 photo with their application, along with a release form found online at the point of submission for the nominee and each recognizable person in the photo.
- Entrant/nominee must be a legal resident of the United States, and eighteen (18) years of age or older.
- Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of the Sponsor and each of its affiliated entities, and any and all other companies associated with the Contest, are not eligible to participate or win (as defined below). The Contest is subject to all applicable federal, state and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation.
- The entry application must be fully completed by the nominee or nominator. Incomplete applications will be disqualified.

Entry Period: The Contest is open between April 6, 2026 until 11:59 p.m. CST on June 5, 2026 (the “Contest Period”). All entries must be received by IDEAg during the Contest Period.

How to Enter:

If you are nominating someone else:

- Complete the application online at <https://www.ideaggroup.com/Dakotafest/woman-farmer-of-the-year-award> on behalf of the nominee during the Contest Period.

- Confirm the nominee is aware of the entry submission.
- Provide at least 1 photo of the nominee, along with a release form, found online at point of submission, for the nominee and each recognizable person in the photo.

- Provide at least 1 photo of yourself along with a release form, found online at point of submission, for you and each recognizable person in the photo

Sponsor:

Dakotafest 2025 Woman Farmer/Rancher of the Year Award is promoted and sponsored by IDEAg Group, LLC, producers of Dakotafest.

Criteria for Selection:

- Nominee has a high level of commitment to the farm/ranch in terms of hours dedicated to her work.
- Nominee has a positive impact on the farm in terms of income, yield, diversification, and/or overcoming challenges.
- Nominee demonstrates not only impact on the farm but also positive impact in her community.
- Application essays or videos share a compelling, creative, humorous, or inspiring story about the nominee.

Winner Selection:

IDEAG's Selection Committee will be made up of the following:

- 3 Dakotafest representatives who work in areas such as marketing, sales and operations.
- 1 representative from the American Farm Bureau Federation Women's Leadership Committee.
- Up to 5 representatives from a third-party sponsoring company

Promptly following the end of the Contest Period, the Selection Committee will review all qualifying applications, and using subjective criteria established above, will select the top 5 applications as finalists. Finalists will be notified on or about June 19, 2026. Finalists will be recognized in media and at the

Dakotafest award ceremony. The winner of the Dakotafest 2026 Woman Farmer/Rancher of the Year award will be selected from the top 5 finalists and will be recognized on stage on August 20, 2026.

Prize:

Each of the top 5 finalists will receive:

- Gift (value not to exceed \$100) in honor of their efforts in farming.
- Recognition in Dakotafest public relations, social media and show program.
- 5 complimentary tickets to Dakotafest

Dakotafest's 2026 Woman Farmer/Rancher of the Year will receive:

- Gift (value not to exceed \$100) in honor of her efforts in farming as part of the top 5 nominees
- Recognition in Dakotafest news releases and social media
- \$1,000 cash prize

General:
